City Engineer Shawn Riggs reported 2023 Street Program and receipt of construction bids. We received four bids and they were opened on March 2, 2023. The lowest bid received was \$318,423.10 from Neyra Paving. After checking references, going over cost projections, and reviewing all aspects of the bid, CT Consultants, recommended awarding the project to Neyra Paving. The streets being fixed are Cleveland Avenue, Forest View Lane, Wilson Road, Parkview Drive, and Hogan Street. Commissioner Kreimborg made a motion to hire Neyra Paving for the 2023 Street Program. Commissioner Braden made a second. The Commission approved by unanimous vote.
