COMMISSION MEETING  
Wednesday, April 13, 2022**

**CALL TO ORDER & WELCOME:**

Mayor Bell called the meeting to order at 6:59 p.m. and welcomed those in attendance. In attendance were Mayor Daniel L. Bell, Commissioner Caroline Braden, Commissioner Mark Kreimborg, Commissioner Rose Merritt, Commissioner Dan Murray, City Administrative Officer Brian Haney, and City Attorney Jack Gatlin.

**INVOCATION/PLEDGE OF ALLEGIANCE:**

Mayor Bell led the invocation followed by the Pledge of Allegiance.

**APPROVAL OF MINUTES:**

**March 9, 2022 – Commission Meeting**

Mayor Bell called for a motion to approve the minutes of the March 9, 2022, Commission Meeting. Commissioner Murray so moved, with a second from Commissioner Merritt. Commissioner Kreimborg abstained. Commission approved by unanimous voice call vote.

**March 23, 2022 – Caucus Meeting**

Mayor Bell called for a motion to approve the minutes of the March 23, 2022, Caucus Meeting. Commissioner Braden was so moved, with a second from Commissioner Kreimborg. Commissioner Murray abstained. Commission approved by unanimous voice call vote.

**ORDINANCE 378 (05-11-22) – FIRST READING**

AN ORDINANCE OF THE CITY OF TAYLOR MILL IN KENTON COUNTY, KENTUCKY REPEALING THE CURRENT TAYLOR MILL ZONING CODE AND ZONING MAP AND REPLACING WITH AN UPDATED ZONING CODE AND ZONING MAP.

City Attorney Jack Gatlin provided the first reading of Ordinance 378 (05-11-22).

City Attorney Jack Gatlin provided the reading of Resolution 368. Mayor Bell called for a motion to approve Resolution 368. Commissioner Kreimborg made a motion with a second from Commissioner Braden. Commission approved by unanimous vote.

City Attorney Jack Gatlin provided the reading of Municipal Order 116. Mayor Bell called for a motion to approve Municipal Order 116 for the sale of lightbars, police radios, and other equipment on Govdeals.com. Commissioner Murray made a motion with a second from Commissioner Merritt. Commission approved by unanimous vote.

**MUNICIPAL ORDER 117**

A MUNICIPAL ORDER OF THE CITY OF TAYLOR MILL, KENTON COUNTY, KENTUCKY APPROVING THE APPOINTMENT OF STUART BOWNS TO THE BOARD OF ADJUSTMENTS FOR THE CITY OF TAYLOR MILL

Mayor Bell called for a motion to approve Municipal Order 117 for the appointment of Stuart Bowns to the Board of Adjustments for the City. Commissioner Braden made a motion with a second from Commissioner Merritt. Commission approved by unanimous vote.

City Administrative Brian Haney requested that the Commission approve the Stormwater Cost Share Request submitted by Debra Ashcraft of 5218 Woodland Drive. Mayor Bell called for a motion to approve Mr. Haney's recommendation of accepting the Stormwater Cost Share Request from Debra Ashcraft. Commissioner Kreimborg so moved, with a second from Commissioner Murray. Commission approved by unanimous vote.

**MOTION CARRIED**

City Administrative Brian Haney requested that the Commission approve the request bid to address the starling bird issue at the firehouse. Mayor Bell called for a motion to approve Mr. Haney's recommendation of accepting the bid to get the starling birds from being able to enter and inhabit the firehouse. Commissioner Merritt so moved, with a second from Commissioner Braden. Commission approved by unanimous vote.

City Administrative Brian Haney requested that the Commission approve the closing of the Western Kentucky Tornado Relief Fund checking account and disperse the funds to the City of Dawson Springs. Mayor Bell called for a motion to approve Mr. Haney's recommendation of closing the Western Kentucky Tornado Relief bank account and disperse the funds. Commissioner Kreimborg so moved, with a second from Commissioner Braden. Commission approved by unanimous vote.

The Commission reviewed reports from the following staff members: City Administrator, Treasurer, Engineering, Fire/EMS, Legal Counsel, Parks and Recreation, Maintenance, and Police.

Mayor Bell called for a motion to approve Mr. Haney's the acceptance of the Rescue Tool Grant. Commissioner Murray so moved, with a second from Commissioner Merritt. Commission approved by unanimous vote.

meeting. The motion passed with the unanimous approval of the Commission, the time being 8:26 p.m.


