The meeting was called to order at 7:00 pm. Commissioner Kuehne gave the invocation, followed by the Pledge of Allegiance led by Mayor Bell. The City Clerk called the roll.

Commissioner Murray made a motion to accept the minutes from the April 10, 2013 Commission Meeting as submitted. Commissioner Reis made a second. Commissioner Murray – Yes, Commissioner Reis – Yes, Mayor Bell – Yes, Commissioner Kreimborg Yes, Commissioner Kuehne – Yes. All Commissioners were in favor.

Introduction of the new Assistant City Clerk/Special Events Coordinator – Michelle M. Frisch by Mayor Bell to Commission and City.

LEGISLATION

City Attorney Frank Wichmann gave a first reading of an Ordinance 290 amending the text of Taylor Mill Zoning Ordinance to reduce the minimum development area in the DTM zones from 5 acres to 2.5 acres

City Attorney Frank Wichmann gave a first reading of Ordinance 291 repealing in their entirety the existing text of the Flood Plain Regulations in Section 9.24 of the Taylor Mill Zoning Ordinance and adopting new Flood Plain Regulations to comply with paragraph 60.3 (D) of the National Flood Insurance Program Regulations 944CFR 59, Etc.)

Mayor Bell introduced a resolution regarding the Municipal Road Aide Agreement for approval by the commission. Commissioner Reis made a motion to approve the agreement. Commissioner Kreimborg seconded that motion. Commissioner Reis – Yes, Commissioner Kreimborg – Yes, Mayor Bell – Yes, Commissioner Kuehne – Yes, Commissioner Murray – Yes. All Commissioners were in favor.

UNFINISHED BUSINESS

Mayor Bell brought to the City and Commissions attention that Sanitation District #1 is proposing a Rate Increase Resolution of 9 to 17 %. No action to be taken but Mayor Bell wanted the City and Commission to be aware and the matter was discussed further.

DEPARTMENT REPORTS

CITY ADMINISTRATOR

Jill Bailey stated there is one item for Executive Session. A discussion regarding the construction on KY 16 on the completion of Phase I and the beginning of Phase II. Discussion regarding the final completion date for Phase I of June 30, 2013. Jill Bailey stressed that there will be significant traffic delays and changes in traffic patterns with this project and to please be careful of any workers city or otherwise in the construction area. Jill Bailey stressed that this project is controlled and managed by KYDOT District 6 and all complaints regarding the project should go to KYDOT District 6.

Jill Bailey discussed the new signage and reflectivity project. Marc Roden will be installing a new post in 2 to 4 wks for review at Old Taylor Mill Road and Sunny Acres. Commissioner Murray inquired about the viability of saving any of the decorative signage. Jill Bailey stated that the old poles currently do not meet the specification height.

ADMINISTRATION

Mike Robke stated he has been working with Michelle Frisch to learn the Clerk duties in the office and she has been working on recreation scheduling. The Shred Event held on April 27, 2013 brought in over 8,000 lbs of paper that were recycled. The Commission discussed the importance of this event due to the issue of identity theft and coordinating this event with Earth Day.


MOTION CARRIED
