CALL TO ORDER & WELCOME:

Mayor Bell called the meeting to order at 7:00 p.m. and welcomed those in attendance. In attendance were Mayor Daniel L. Commissioner Merritt led the invocation followed by the Pledge of Allegiance.

APPROVAL OF MINUTES:

August 10, 2022 - Commission Meeting

Mayor Bell called for a motion to approve the minutes of the August 10, 2022, Commission Meeting. Commissioner Murray so moved, with a second from Commissioner Kreimborg. The Commission approved by unanimous voice call vote.

Mayor Bell called for a motion to approve the minutes of the September 7, 2022, Public Hearing. Commissioner Merritt was so moved, with a second from Commissioner Kreimborg. The Commission approved by unanimous voice call vote.

Aubrey Adams, a resident at 693 Wischer Drive addressed the Commission regarding complaints against his property.

Molly Matracia, a resident at 691 Wischer Drive addressed the Commission regarding Mr. Adams. Ms. Matracia stated that Mr. Adams is a wonderful neighbor and feels that they have been unfairly harassed.

Shirley Reinersman, a resident at 4 N. Janet Drive addressed the Commission regarding problems with her neighbors at 6 N. Janet Drive. Ms. Reinersman provided the Commission with letters from other residents experiencing the same issues.

August Chalk, a resident at 691 Wischer Drive asked the Commission about future plans for sidewalks on Taylor Mill Road.

Dale Adams, a resident at 688 Wischer Drive addressed the Commission and stated his support for Mr. Adams.

LEGISLATION: Legislation was sent to and received by the commission prior to the meeting.

ORDINANCE 381 (09-28-22) – FIRST READING

AN ORDINANCE OF THE CITY OF TAYLOR MILL, IN KENTON COUNTY, KENTUCKY, PROVIDING FOR THE ANNUAL ASSESSMENT OF ALL REAL ESTATE AND PERSONAL PROPERTY, WITHIN THE CORPORATE LIMITS OF THE CITY OF TAYLOR MILL, AND THE AD VALOREM TAXATION THEREOF, FOR THE FISCAL YEAR BEGINNING ON JULY 1, 2022 AND ENDING ON JUNE 30, 2023 AND PROVIDING FOR THE PAYMENT AND COLLECTION OF SUCH TAXES, AND THE PENALTIES AND INTEREST THEREON; AND DESCRIBING THE PURPOSE FOR WHICH THE TAXES SO COLLECTED SHALL BE APPROPRIATED AND USED.

City Attorney Jack Gatlin provided the first reading of Ordinance 381. The ad valorem tax on real property rate is \$0.452 for each One Hundred (\$100.00) Dollars, and an ad valorem tax on all personal property at the rate of \$0.533 Dollars for each One Hundred (\$100.00) Dollars of the value thereof.

ORDINANCE 382 (09-28-22) – FIRST READING

AN ORDINANCE OF THE CITY OF TAYLOR MILL, IN KENTON COUNTY KENTUCKY, IMPOSING A SOLID WASTE COLLECTION FEE ON ALL SINGLE-FAMILY RESIDENTIAL LOTS AND STRUCTURES IN THE CITY AND THE OWNERS THEREOF

City Attorney Jack Gatlin provided the first reading of Ordinance 382. The annual solid waste collection fee for single-family residents will be \$179 for the fiscal year.

MUNICIPAL ORDER 121 – SURPLUS OF PROPERTY

A MUNICIPAL ORDER OF THE CITY OF TAYLOR MLL IN KENTON COUNTY KENTUCKY MAKING THE WRITTEN DETERMINATIONS REQUIRED BY KRS 82.083 FOR THE SALE OR OTHER DISPOSITION OF PROPERTY OWNED BY THE CITY

City Attorney Jack Gatlin provided the reading of Municipal Order 121. Mayor Bell called for a motion to approve a Municipal Order for the sale of handheld radios, shoulder mics, tasers, portable radios, a 2009 Dodge Charger, and other miscellaneous police equipment on iGov Deals. Commissioner Merritt made a motion with a second from Commissioner Kreimborg. Commission approved by unanimous vote.

RESOLUTION 370 - Kentucky Office of Homeland Security Project

City Attorney Jack Gatlin provided the reading of Resolution 370 authorizing Mayor Bell to make an application to enter into an agreement with the Kentucky Office of Homeland Security to facilitate for the Law Enforcement Protection Program fund.

Mayor Bell called for a motion to approve Resolution 370 authorizing him to sign the application for a grant to obtain ballistic vests. Commissioner Murray made a motion with a second from Commissioner Braden. Commission approved by unanimous vote.
