CALL TO ORDER & WELCOME:

PUBLIC HEARING:

City Administrator Brian Haney provided the proposed tax rate for 2019 as being .458 per one hundred dollars of value thereof. For personal property the tax rate is .772 per one hundred dollars of value thereof.

Mayor Bell invited anyone in the audience to speak. No one came forward. There being no further business, to discuss, Mayor Bell closed the Public Hearing at 7:04pm.

LEGISLATION:

SECOND READING – ORDINANCE 350

AN ORDINANCE OF THE CITY OF TAYLOR MILL, IN KENTON COUNTY, KENTUCKY, PROVIDING FOR THE ANNUAL ASSESSMENT OF ALL REAL ESTATE AND PERSONAL PROPERTY, WITHIN THE CORPORATE LIMITS OF THE CITY OF TAYLOR MILL, AND THE AD VALOREM TAXATION THEREOF, FOR THE FISCAL YEAR BEGINNING ON JULY I, 2019 AND ENDING ON JUNE 30, 2020 AND PROVIDING FOR THE PAYMENT AND COLLECTION OF SUCH TAXES, AND THE PENALTIES AND INTEREST THEREON; AND DESCRIBING THE PURPOSE FOR WHICH THE TAXES SO COLLECTED SHALL BE APPROPRIATED AND USED.

SECOND READING – ORDINANCE 351

AN ORDINANCE OF THE CITY OF TAYLOR MILL, IN KENTON COUNTY, KENTUCKY, AMENDING TAYLOR MILL ORDINANCE NO. 337 (10-10-18) BY INCREASING THE RATE OF THE ANNUAL WASTE COLLECTION ASSESSMENT LEVIED THEREBY TO ONE HUNDRED EIGHTY-TWO DOLLARS (\$182.00) PER YEAR.

Attorney Frank Wichmann provided the second reading of Ordinance 351. Mayor Bell called for a motion to approve Ordinance 351. Commissioner Murray made a motion with a second from Commissioner Merritt. Commission approved by unanimous vote.

City Attorney Frank Wichmann read the Resolution. Mayor Bell called for a motion to approve Resolution 341. Commissioner Braden motioned with a second from Commissioner Merritt. Commission approved by the following vote.

NEW BUSINESS:

Mr. Haney discussed the need to push Keavy Dam, Mason Road & Reidlin Road slips to the forefront so that they can get fixed.

Mr. Haney explained that the city has an opportunity to join alongside SD1 to work on Keavy Dam because it is failing. Mr. Haney requested the Commission to partner with SD1 to fix Keavy Dam with the caveat of him speaking the property owner about getting the trees removed from the side of the road. Mayor Bell asked for a motion to approve Mr. Haney's recommendation of partnering with SD1 to get a pier wall on the lower side of the dam to help keep the soil and asphalt intact. Commissioner Braden so moved, with a second from Commissioner Merritt. Commission approved by unanimous vote.

MOTION CARRIED

Mr. Haney discussed the need for the Mason Road slip to be fixed. Mr. Haney is requesting the other road projects to be suspended until next year and focus on getting the Mason Road slip fixed. Mayor Bell asked for a motion to approve Mr. Haney's recommendation. Commissioner Murray so moved, with a second from Commissioner Braden. Commission approved by unanimous vote.

DEPARTMENT REPORTS:

The Commission reviewed reports from the following staff members: City Administrator, Treasurer, Engineering, Fire/EMS, Legal Counsel, Parks and Recreation, Maintenance and Police.

Police Chief Knauf expressed concern about the shortage of manpower due to recent injuries and changes in staff. Commission Kreimborg made a motion to hire Officer Mathew Hicks, effective September 23, 2019. Commissioner Merritt seconded. Commission approved by unanimous vote.
