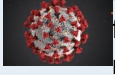

## City Tax Rates Set

The Taylor Mill City Commission voted unanimously to not raise property taxes this year. The tax rate of \$4.54 per thousand or **0.454** dollars per \$100.00 was adopted. The city elected to use the compensating rate to determine our property taxes for fiscal year 2021. Using the compensating the city commission was able to reduce the 2020 property tax rate from \$4.58 per one thousand to the rate of \$4.54 per one thousand. The new rate saves property owners a little money. The commission has agreed to hold ad valorem tax on all personal property at the rate of **\$.772** dollars for each One Hundred (\$100.00) dollars of the value thereof. Tax bills should go out the first week of October and are due by December 31, 2020.

## Census Update

### Census Response

Taylor Mill currently has a 80.1% for filling out the 2020 census. And ranks #85 in response for Kentucky. Kenton County ranks #17 out of 120 counties. Residents still have until September 30, 2020 to register. It is important to say registering means federal dollars to our area so please If you know anyone who has not registered please either assist them or call the city and our staff will assist them.
