

ORDINANCE NO. 365 (02/10/2021)

AN ORDINANCE OF THE CITY OF TAYLOR MILL IN KENTON COUNTY KENTUCKY, CHANGING THE HOUSE NUMBERS AND/OR STREET ADDRESSES OF VARIOUS PARCELS OF REAL ESTATE IN THE CITY

WHEREAS, ever since the construction of Pride Parkway (KY 16), multiple streets and addresses have been disrupted; and

WHEREAS, streets such as Robertson Road have been cut in half by such construction and a large portion of Old Taylor Mill Road was simply replaced by Pride Parkway; and

WHEREAS, the logistical issues for common carriers such as UPS and FedEx have been evident from the beginning; but now issues have developed with first responders being unable to locate addresses that don't correspond with the 911 software in use by the Kenton County Dispatch Center;

WHEREAS, this issue is dangerous to the health, safety and welfare of the residents and occupants of such streets instead of being a mere inconvenience; and

WHEREAS, in reviewing the issues of street names and addresses resulting from the construction of Pride Parkway it was decided to also resolve the issue of the four (4) streets in the City with the same name; i.e., Janet Drive, Robertson RD, Sunset PL, and Valley View LN. The parcels of property on those streets will keep their current street addresses; but some of those streets will have an "N" or "E" directional prefix before the street name to clearly separate it from its twin;

NOW, THEREFORE, for the purpose of eliminating the aforescribed confusion in street names and addresses in the City; and the consequential hazards to the health, safety and welfare of the occupants and residents of the parcels of real estate affected thereby;

BE IT ORDAINED BY THE CITY OF TAYLOR MILL, IN KENTON COUNTY, KENTUCKY, AS FOLLOWS:

Section 1.0 – New Parcel House Numbers and Street Addresses

The Current House Numbers and Current Street Addresses of the parcels of property identified by their Parcel Identification Numbers (PIDN) in the attached Schedule are hereby changed to the respective New House Numbers and New Street Addresses provided for them in the attached Schedule.

Section 2.0 – Conflicting Ordinances Repealed

All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed to the extent of such conflict.

Section 3.0 – Effective Date

This ordinance shall be effective as soon as possible according to law.

Section 4.0 Publication


