ORDINANCE NO. 300 (06-11-2014)

AN ORDINANCE OF THE CITY OF TAYLOR MILL, IN KENTON COUNTY, KENTUCKY, ADOPTING A BUDGET FOR THE CITY OF TAYLOR MILL PURSUANT TO K.R.S. 91A.030 (10) FOR THE FISCAL YEAR BEGINNING JULY 1, 2014, AND ENDING ON JUNE 30, 2015, AND PROVIDING THAT NO MONIES SHALL BE EXPENDED BY OR ON BEHALF OF THE CITY OF TAYLOR MILL EXCEPT IN ACCORDANCE THEREWITH; AND PROVIDING THAT NO SINGLE APPROPRIATION AND EXPENDITURE IN ACCORDANCE THEREWITH SHALL EXCEED THE SUM OF \$2,500.00 WITHOUT THE PRIOR APPROVAL OF THE TAYLOR MILL COMMISSION THEREFOR.

BE IT ORDAINED BY THE CITY OF TAYLOR MILL, IN KENTON COUNTY, KENTUCKY, AS FOLLOWS:

SECTION I

Pursuant to the requirement of K.R.S. 91A.030 (10) the City of Taylor Mill shall during the fiscal year beginning on July 1, 2014, and ending on June 30, 2015, operate and be operated pursuant to the budget attached hereto and made a part hereof by reference; and no monies shall be expended by or on behalf of the City of Taylor Mill except in accordance therewith; and no single appropriation and expenditure in accordance therewith shall exceed the sum of \$2,500.00 without prior approval of the Taylor Mill Commission therefor.

SECTION II

The provision of this ordinance are severable; and the invalidity any provision of this ordinance shall not affect the validity of any other provisions thereof; and such other provisions shall remain in full force and effect as long as they remain valid in the absence of those provisions determined to be invalid.

SECTION III

All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed to the extent of such conflict.

SECTION IV

This ordinance shall be effective as soon as possible according to law.

SECTION V

This ordinance shall be published in summary pursuant to K.R.S. 83A.060(9).

NARRATIVE

Ordinance No. 300 (06-11-2014) of the City of Taylor Mill was enacted by the City Commission thereof on June 11, 2014; and it is an ordinance establishing a budget for the City for the fiscal year beginning on July 1, 2014, in which total available funds are anticipated to be \$8,854,157.00, with \$4,057,536.57 of anticipated expenses in the General Fund, \$335,950.00 in the M.R.A. Fund, \$297,635.95 in the Recreation Fund, \$3,283,750.00 in the Capital Imp. Fund, \$79,575.00 in the Com. Events Fund, and \$6,450.00 in the Senior Serv. Fund for total anticipated expenses of \$8,000,897.52 and an anticipated fund balance of \$793,259.48 at the end of the FYE 2015. Additionally, the ordinance provides that no monies shall be expended by or on behalf of the City except in accordance with that budget; and no single appropriation and expenditure shall exceed the sum of \$2,500.00 without the prior approval of the Taylor Mill City Commission.
