

# November 2022 Supplemental Report

During this month's commission meeting I will be recognizing Sgt. Matt Hicks for his work as it relates to the arrest of Shannon Gilday. As you might recall Mr. Gilday was arrested in relation to a home invasion and homicide in Richmond, Kentucky. I stand by the fact that had it not been for Sgt. Hick's follow through KSP would not have identified this suspect as quickly as they did.

The hiring process is on-going and we are working through the candidates' backgrounds. We have encountered some scheduling delays as it relates to testing. I am hoping to have recommendations to you at the December meeting.

All TMPD officers will be participating in Active Threat training in December. This training is going to be conducted at Scott High School. Some protective training equipment has been purchased and will be used during this training. It is the goal of the police department to conduct this training at several points throughout the year.

All TMPD officers will be participating in our annual low light qualifications on November 28, 2022. This will be the first time that officers are qualifying with the new equipment that was purchased for all of the PD's rifles. This purchase was part of our annual budget request and I thank the Commission for the approval of this purchase. I would encourage the Mayor and Commissioner to please reach out to me if you would like to attend the qualification and see one of the ways that the PD remains professional.

We are currently in the process of having approximately 25% of our CALEA Accreditation files ready for review. This review will take place during the first and second week of December. Also, we have been awarded our 5<sup>th</sup> consecutive Kentucky Association of Chief's of Police Accreditation.
