### New Commission to be sworn in December 21st, 2018

I am honored to welcome the newly elected members of the Taylor Mill City Commission, Commissioner & vice mayor-elect Mark Kreimborg, Commissioner-elect Dan Murray, Commissioner-elect Caroline Braden, and Commissioner-elect Rose Merritt.

I also want to take this opportunity to thank the voters of Taylor Mill for allowing me to continue my work representing Taylor Mill as your Mayor. I encourage every citizen to attend at least one of the commission's meetings. It is always beneficial to have the citizens engaged in the city business.

The Mayor and City Commissioners will be sworn in on December 21st at 6:00 p.m. and will take the oath of office effective January 1, 2019. We will be posting bios of the commissioners to the city website for your review.

#### **Phase II Sidewalk Update**

As mayor, I have made it a focus to seek opportunities to enhance our city, and I will continue to be engaged in those efforts. I have been working on our sidewalk project for several years, and I am committed to seeing the project for several years, and I am committed to seeing the project through to completion. Completing the sidewalk project benefits the Public Health & Safety of our residents by providing a safe route to schools, connecting our community and improving access to our park and recreation activities.

Phase II of the sidewalk project, from Saddlebrook to Pride Park, will be rebid in Spring 2019. As you may know, the bid the city received in July 2018 was way over our budget, so we are rebidding the project in hopes of getting a better price. In light of the need for additional funds, I am pursuing additional SNK funds from OKI. If OKI approves additional funds for phase II, the sidewalk can be completed in 2019.

In October 2018, the city was selected to receive \$846,424.00 in SNK funds to complete phase III. This grant will allow all three phases to be completed by 2021. The pursuit of grant funding to complete the sidewalk project saves city funds and taxpayers' dollars to be used on other projects.

#### **Play Ground Equipment Repair Update**

The goal of the new city commission is to have the park play-ground repaired by Spring 2019.

## **AQs ABOUT YOUR TAX BILL:** What if my tax bill should go to my mortgage company and I received it? If that

- happens you should forward your tax bill to them. What if I have only lived in my home for less than one year and the previous owner
- should pay for his portion of my tax bill? Check with your closing agent. Credit for the seller's portion of the tax bill should have been provided to you on your closing statement and therefore the bill is your responsibility. What if I sold the property and no longer live there but the bill came and is in my name? By
- state law, the bills come out with the name of the owner of record as of January 1, 2018. If you have sold the property you may simply forward that bill to the new owner, or contact our office and we will forward a copy to them. What if I am entitled to an exemption (Homestead or Disability) and I am not seeing it on
- 1750). You must contact them and apply. If granted they will contact the city with the new amount of value of your property and the city will issue you a revised tax bill. We can't do this on your behalf.
