ORDINANCE NO. 329 (1-10-18)

AN ORDINANCE OF THE CITY OF TAYLOR MILL, IN KENTON COUNTY, KENTUCKY, AMENDING THE PERSONNEL PAY AND CLASSIFICATION PLAN TO PROVIDE FOR EMPLOYEE BONUSES AND EXTRA PAY

WHEREAS, the Personnel Pay and Classification Ordinance136 (06-17-98) of the City includes no provisions for bonuses or extra pay; and

WHEREAS, there are times when the performance and accomplishments of an employee is above and beyond that required by the functions and duties of the job classification thereof; and the City needs the discretion to reward such employees with a one time bonus or extra pay for such extraordinary performance;

NOW THEREFORE, BE IT ORDAINED BY THE CITY OF TAYLOR MILL, IN KENTON COUNTY KENTUCKY, AS FOLLOWS:

SECTION I

The Taylor Mill Personnel Pay and Classification Ordinance 136 (06-17-98), as previously revised and amended from time to time, is hereby again amended to add a new section that authorizes bonuses and extra pay for extraordinary performance and accomplishments by employees, all in conformity with the language in ATTACHMENT A to this ordinance, which is incorporated herein by reference, with the words, letters and numbers being added indicated by a single solid line beneath them, as required by KRS 83A.060.

SECTION II

The provision of this ordinance are severable; and the invalidity any provision of this ordinance shall not affect the validity of any other provisions thereof; and such other provisions shall remain in full force and effect as long as they remain valid in the absence of those provisions determined to be invalid.

SECTION III

All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed to the extent of such conflict.

SECTION IV

This ordinance shall be effective as soon as possible according to law.

SECTION V

This ordinance shall be published in summary pursuant to K.R.S. 83A.060(9).

ATTACHMENT A

Notwithstanding any other provision of this ordinance to the contrary, the City Commission may, after the consideration of all relevant factors, including, without limitation, the education, experience, performance, merit and longevity of an employee, authorize a one time per year bonus or extra pay in a specific amount to that employee for performance or accomplishments that are above and beyond that required by the functions and duties of the job classification thereof; but only through the passage of a Motion to authorize that bonus or extra pay at a regularly scheduled meeting of the City Commission.
