

**ORDINANCE NO. 353 (12-11-2019)**

**AN ORDINANCE OF THE CITY OF TAYLOR MILL IN KENTON COUNTY KENTUCKY AMENDING SUBSECTION N. OF SECTION II OF ORDINANCE No. 28 (9-11-91) IN REGARD TO MOTOR VEHICLE PARKING ON PRIMROSE DRIVE**

**WHEREAS**, Taylor Mill Ordinance No. 28 (9-11-91) establishes regulations for the parking of motor vehicles on various streets in the City, including, without limitation, Primrose Drive in subsection N.; and

**WHEREAS**, the regulations in Taylor Mill Ordinance No. 28 (9-11-91) of the parking of motor vehicles on Primrose Drive are in need of amendment to promote the public health, safety, convenience and welfare;

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF TAYLOR MILL IN KENTON COUNTY KENTUCKY, AS FOLLOWS:**

**Section 1.0 – Ordinance Amendment**

The regulations in subsection N. of Section II of Taylor Mill Ordinance No. 28 (9-11-91) of the parking of motor vehicles on Primrose Drive are hereby amended to conform to the language in ATTACHMENT A to this ordinance, which is incorporated herein by reference, with the text being added indicated by a single solid line beneath them and the words being removed marked at the beginning with an opening bracket and at the end with a closing bracket and the text between them stricken through with a single solid line, as required by K.R.S. 83A.060(3)

**Section 2.0 – Provisions Severable**

The provisions of this ordinance are severable; and the invalidity of any provision of this ordinance shall not affect the validity of any other provision thereof; and such other provisions shall remain in full force and effect as long as they remain valid in the absence of those provisions determined to be invalid.

**Section 3.0 – Conflicting Ordinances Repealed**


Taylor Mill Ordinance 28 (9-11-91) and all other ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed to the extent of such conflict.

**Section 4.0 – Effective Date**

This ordinance shall be effective as soon as possible according to law.

**Section 5.0 - Publication**

### **SECTION II**

Nobody shall cause, permit, encourage, allow, aid, assist or engage in the location of any parked motor vehicle in any of the following described areas within the City of Taylor Mill:

N. On the [~~north~~] south side of Primrose Drive within [~~forty~~] thirty feet of Church Street.
