# Taylor Mill Sidewalk Phase 3 KYTC Item No. 6-463 Public Engagement Information

## Why is this project being done?

This project is the third phase of the Cities efforts to provide sidewalks along Taylor Mill Road, which serves as a major collector route through the City. Currently there is no sidewalk along Taylor Mill Road (KY 3716) between Saddlebrook Drive to the south and Walnut Street to the north. As a result, pedestrian are forced to walk on the roadway pavement or along uneven terrain outside of the pavement. The proposed improvements would create a safe, traversable walkway, which would allow for pedestrian to travel along Taylor Mill Road to get to businesses, restaurants, churches, and the park.

### What does this project include?

This project will complete the sidewalk gap that exists along the along the north/east side of Taylor Mill Road between Saddlebrook Drive to the south and Walnut Street to the north. Once this project is completed, a continuous segment of sidewalk will exist from along Taylor Mill Road form Pride Parkway (KY 16) to Old Taylor Mill Road at the shopping center. An approximate 5-mile sidewalk loop along Taylor Mill Road, Old Taylor Mill Road and Pride Parkway will also be created with the construction of the proposed sidewalk.

## **Funding Sources**

The City of Taylor Mill is receiving federal transportation funding for locally administered transportation projects Through the Kentucky Transportation Cabinet's (KYTC) Local Public Agencies (LPA) program. The following funds are to be used:

- Surface Transportation Program for Northern Kentucky (SNK) Funding (Federal funds)
- City of Taylor Mill Local Funds

### Possible impacts to existing conditions, residents, and property owners

During the design phase of this project, public input will help the project team understand the concerns and interests of adjacent property owners and the general public. The sidewalk alignment will be designed to minimize disruption to the surrounding area. In some areas, utilities will need to be relocated, trees will need to be removed and grading easements will be requested from affected property owners. The reconstruction of some driveways will be necessary as a part of the project. The project team will work with individual property owners to mitigate impacts to the extent possible.

#### **Timeline**

This project is tentatively scheduled for construction in the Spring/Summer of 2023.

### **Public Meeting & Survey**

Civil engineering consultants to the City of Taylor Mill, CT Consultants, will present conceptual design information for the Taylor Mill Phase 3 project on November 22, 2021 at 7:00 P.M at the Taylor Mill Municipal Building located at 5225 Taylor Mill Rd., Taylor Mill, KY 41015.

The meeting will include a brief presentation by the design team and provide the public an opportunity to provide comments regarding this project as well as potential impacts to environmental or historical resources. Representatives of the City and members of CT Consultants will be available to provide information on various aspects of this proposed project. The presentation materials include design details and aerial plan imagery depicting the conceptual alignment of the proposed Phase 3 sidewalk as well as the latest project schedule.
