



# Pride Park Shelter Rules

Nobody other than officers and employees of the City shall cause, promote, permit, allow, aid, assist, encourage, or engage in any of the following activities or occurrences within Pride Park.

## Park Hours: Sunrise to Dusk

1. No glass containers or bottles.
2. No open fires except in the park grills near the shelters.
3. No smoking and vaping beneath the shelter.
4. Vehicles are not allowed in the grass.
5. Noise ordinance is strictly enforced.
6. No use of firearms, projectiles, or fireworks.
7. The location or use of any tents on the premises must be pre-approved by the CAO. Tents can not exceed the 10x10 size. No stakes allowed.
8. No use of inflatables/play apparatuses or mechanical rides allowed.
9. No confetti of any kind. No silly string, glitter, confetti bombs, piñatas, tape, paint, sidewalk chalk, raw eggs, throwing of rice, or other materials can be used.
10. No objects such as tacks, staples, wires, nails, or tape of any kind may be affixed to any plants, trees, or any structure in the shelters or park.
11. Do not staple or tack items to the tables or pavilion. Please use clips.
12. The employment, use, or any other activation or operation of any musical instrument or device requires prior authorization from the Taylor Mill City Commission.
13. Clean-up is required after shelter rental. All tables must be returned to their original spots.
14. Place all trash in shelter receptacles.
15. The presence of anybody within the boundaries of the park any time after dusk and before dawn, requires authorization from the Taylor Mill City Commission.
16. Any activity that disturbs or interferes with anybody else using the park or any property adjacent thereto is not permitted.
17. Pets are required to be leashed and controlled by the owner or custodian; owners must clean up after their pets and dispose of waste in a trash receptacle.
18. No hunting, trapping, or in any way injuring or molesting any animal within the park.
19. No servicing or repairing any vehicle or other equipment.
20. No skateboarding, roller skating, rollerblading, etc. in any area of the park.
21. No bicycling in any area other than the paved parking lot and the paved roadway (excluding the walking/hiking trails).
22. No swimming or wading in any pond or other impoundment of water.
23. No display, location, placement, posting, or distribution of any sign, advertisement, circular notice, statement, banner, emblem, or design is allowed without permission from the Taylor Mill City Commission.
24. No operation of and use of any musical instrument in combination with any other musical instrument or sound amplifier without authorization from the City Administrator.
25. Motor vehicles are permitted only on paved roadways and parking lots. No access to any paved or unpaved walking/hiking trails is permitted.
26. The operation of any vehicle at a speed over 15 m.p.h.
27. No vehicles may be left overnight.
28. All trash must be disposed of in trash cans.

**\*\* Alcoholic beverages must be kept within 10 feet of the shelter house. Glass containers are prohibited.**

**Failure to adhere to the rules could result in the loss of the deposit and additional charges could occur to clean the facility.**
