

TAYLORED WITH TIME SENIOR CITIZENS GROUP

Rules & Regulations

The City of Taylor Mill welcomes citizens, age 50 and older, to the “Taylored with Time” Senior Citizens Group.

This program was established in July of 2008 to offer recreational and educational activities that focus on the needs and well being of seniors in our community.

The “Taylored with Time” Senior Citizen’s Program will be open to members every Wednesday from 9:00 a.m. until 3:00 p.m. (closed on city-recognized holidays). Program activities will be held at Park Place Community Center, located at 5606 Taylor Mill Road, Taylor Mill, KY 41015, unless otherwise scheduled offsite at various locations.

The following policies will govern the “Taylored with Time” Senior Citizens Group.

- The program will be open to members every Wednesday from 9:00 a.m. until 3:00 p.m.
- Programming will be held at Pride Park Community Center, with special activities to be scheduled offsite at various locations to be announced.
- The Program is open to Taylor Mill residents only for full membership. Proof of residency is required to be submitted for verification. Acceptable forms of verification are a valid driver’s license, a Commonwealth of Kentucky personal identification card or a recent utility bill. Exceptions to this rule are limited to family members of full time City of Taylor Mill employees who are in good standing, and at the discretion of the City Administrator.
- Full members must be age 50 or older and able to care for themselves, unassisted. We accept all residents as full members without regard to political affiliation, race, color, national origin, sex, religion, or sexual preference.
- Full members must pay annual dues of \$25.00 per fiscal year. The fiscal year will begin on July 1, and end on June 30. Failure to pay dues in the time frame established will cause the termination of all membership rights and privileges. Dues will be prorated on the following schedule for **new**

members only so that residents of Taylor Mill will not have to wait until the next membership day to become a member of the “Taylored with Time” Senior Citizen’s Program. Proration is only for **new members**. July 1st - \$25.00, October 15th - \$20.00, January 15th - \$15.00, April 15th - \$10.00.

- Each full member may bring two (2) associate members. Associate members must be age 50 or older, care for themselves unassisted, and do not have to reside within the city limits. We accept all associate members without regard to political affiliation, race, color, national origin, sex, religion, or sexual preference. Associate membership is \$30.00 per fiscal year. All associate members must be accompanied by a full member who is in good standing with the organization. An associate member may only be a member if their sponsor (full time member) is a member. Dues will be prorated on the following schedule **for new members only** so that Associate members who are sponsored by a resident of Taylor Mill will not have to wait until the next membership day to become a member of the “Taylored with Time” Senior Citizen’s Program. **New Members only** will pay July 1st - \$30.00, October 15th - \$25.00, January 15th - \$20.00, April 15th - \$15.00.
- Interested individuals who qualify for full membership may receive a one-day free trial pass before deciding if they would like to become a full dues-paying member. Only one free trial membership will be issued per qualifying member during the fiscal year. Interested individuals on a trial pass are responsible to cover the cost of their lunch.
- Scheduled activities may be closed due to inclement weather conditions. Generally, if Kenton County Schools are closed due to snow/ice then Park Place Community Center will also be closed.
- Additional fees may apply for some special activities, programming and/or events. Participation in these special opportunities will be voluntary and announced in advance. Payment must be received **one (1) month** prior to the date of the scheduled trip, unless otherwise noted. Any cancellations must be made **two (2) weeks** prior to the date of the trip for a full refund unless there is a medical emergency which prevents the member from attending (**documentation required**). **Any cancellations made after that time will not be refunded. Guests will not be issued a refund for any reason.**

- Programming and Event participation may be limited. As a result reservations for participation may be required, or on a first come – first served basis.
- Rude, disruptive, offensive, and/or discourteous behavior and/or gestures are strictly prohibited and cause for termination of your membership.
- The City of Taylor Mill Chief Administrative Officer shall be responsible for interpreting and making any exceptions to the policies established governing the “Taylored with Time” Senior Citizens Group.
- Membership may be terminated at the discretion of the City Administrator for any reason, or no reason, at all.

The following policies govern the use of Pride Park Community Center, and may not be applicable to any programming, activities, and/ or events held off site.

- Smoking within the facility is strictly prohibited.
- The use of the kitchen stoves/microwaves are restricted to warming only. Cooking inside the facility is strictly prohibited, unless otherwise authorized by the City of Taylor Mill Chief Administrative Officer.
- Sound amplification should not reach a level determined by any police officer of the City to be disruptive to the public peace.
- There shall be no operation and use of any musical instruments, without the written authorization of the Taylor Mill Chief Administrative Officer.
- The use of candles or other open flames in the building other than in a fireplace or a glass container, such as a votive light or hurricane lamp is strictly prohibited.
- The use of glitter, rice, birdseed, confetti, or other fine materials shall be strictly prohibited.
- The use of helium balloons in any room with a ceiling fan is strictly prohibited.
- The use of any type of adhesive (tape, 3M, putty, tacks, etc.) to hang decorations on doors, wall, counters, cabinets, etc is strictly prohibited.
- All motor vehicles must be operated and parked on paved areas that are concrete, gravel, or blacktop.
- The use of bubbles or bubble machines in the facility is strictly prohibited.
- No coolers are allowed inside of the facility.

- The use or location of any glass container or bottles outside of the facility is strictly prohibited.
- Pets of any type are strictly prohibited unless to assist the handicapped.

The following policies govern the use of Pride Park, and may not be applicable to any programming, activities, and/or events held off site.

- The discharge or display of any fireworks without both a state permit and specific authorization from the Taylor Mill City Commission.
- The operation of any vehicle in excess of 15 miles per hour is strictly prohibited.
- Any animal in the park which is not leashed or otherwise controlled by the owner or custodian; which constitutes a physical threat to human beings or other animals by its demeanor or actions; any animal that constitutes a nuisance by odor, noise or any other means is strictly prohibited.
- The operation of any motor vehicle anywhere other than the paved roadway (excluding all walking/hiking trails) and parking lot is strictly prohibited.
- Swimming or wading in any pond or other impoundment of water is strictly prohibited.
- Open fires without the written consent of both the Taylor Mill Fire Chief and the Taylor Mill City Commission is strictly prohibited.
- Hunting, trapping or in any way injuring or molesting any animal within the park is strictly prohibited.
- Servicing or repairing a vehicle on park property is strictly prohibited.
- Skateboarding, roller skating, roller blading, etc in any area of the park is strictly prohibited.
- Bicycling in any area other than the paved parking lot and the paved roadway (excluding the walking and/or hiking trails) is strictly prohibited.
- Any activity that disturbs or interferes with anybody else using the park or any property adjacent thereto is strictly prohibited.
- The employment, use or any other activation or operation of any musical instrument without specific authorization from the Taylor Mill City Commission.

- The display of anything for sale or trade without specific authorization from the Taylor Mill City Commission.
- The display, location, placement, posting or distribution of any sign, advertisement, circular notice, statement, banner, emblem or design.
- The possession of any alcoholic beverage that is not within 10 feet of the shelter house is strictly prohibited.
- The use of glass containers is strictly prohibited.

ASSOCIATE MEMBER GUIDELINES

1. A full-time, dues-paying Taylor Mill resident MUST sign for an associate member.
2. Each full-time member may sign for two (2) associate members only.
3. An associate member may not bring a guest with them.
4. An associate member may only be a member of the Taylored with Time Senior Group as long as their sponsor is a member in good standing.
5. Dues for an associate member will be \$30.00 per fiscal year, July 1st – June 30th, see the prorated schedule of dues in the associate member paragraph on the first page for new members only. Dues may be increased without prior notification each year.
6. Associate members are subject to all rules and regulations of the Taylored with Time Senior Group.
