AN ORDINANCE OF THE CITY OF TAYLOR MILL, IN KENTON COUNTY, KENTUCKY, AMENDING CHAPTER 75 OF THE TAYLOR MILL CODE OF ORDINANCES RELATED TO PARKING SCHEDULES
